Dear Friends,

What a difference a day makes! Yesterday was all about ice. Most streets and roads are passable this morning. But February is soon to arrive and while winter is not over yet, one sign of spring is the days getting longer. Another sign of the coming of Spring is that the Lenten season begins on Ash Wednesday, February 14. Yes, St. Valentine's Day.

Now I don't remember these two days coinciding during my lifetime, but a quick internet search turned up that 1945 was the last time this happened. Is there a connection between these two days? Ashes and penance are quite different from chocolate and roses, after all. But if there is a connection, perhaps it is the gift of love. Love, of course, is central to our faith. We remember Jesus' teaching of the Greatest Commandment. "You shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength. The second is this, you shall love your neighbor as yourself." (Mark 12:29-31) Some of the most beautiful and challenging words of scripture are Paul's hymn to Christlike love in I Corinthians 13. That chapter, often read at weddings, ends with these words. "Now faith, hope, and love remain ... these three things ... and the greatest of these is love."

As we enter the holy season of Lent, we are reminded of love's beauty and challenge. We remember a love so deep that God gave us the gift of Jesus Christ. It is Jesus, in turn, who reminds us that God's love for us is to be mirrored in our love for God and all people, even our enemies. During our Lenten journey we follow Jesus as he walks to the cross. That is a journey of teaching, healing, and serving, but above all, it is a journey of love. Can we love as Jesus loves? That is a powerful question that will us lead into, through, and beyond the Lenten season. That is a question for all seasons.

St. Peter's UCC Missions Report December 2023

Free Clinic	The Free Clinic saw five patients in December. The day went very smoothly. Nurse Leesa and Volunteer Janet Alspach discussed gathering and distributing extra over- the-counter products from the congregation to give to needy patients.
The Harvest Table	The Harvest Table provided 771 meals in December. Besides providing nutritious meals to the guests, they also provided needed sleeping bags, tents, and sleep mats. We hear that the volunteers were "Great!" Nurse Leesa saw additional patients and provided necessary care.
WERF	The Washington Emergency Relief was able to answer 236 calls and assist 91 of those community members in December with 31 grants totaling \$6,543.57. Ten of those grants were for electricity, four for water, fifteen for rent, and two for miscellaneous items.



St. Francis Borgia Food Pantry sent a note thanking the Festival of Trees for the donation of over 8,500 can goods items to the Borgia Food Pantry which served over 1,717 families in 2023.

These frigid temperatures are always tough for people, especially those on the streets. Due to the generous donations of many of the St. Peter's church members and organizations, we will be able to help more of our neighbors stay warm.

The Washington Emergency Relief would like to give a huge thank you to Ron & Brenda Brinker, Kirk & Cindy Kriete, Ruth Rinne, Royce & Mary Lovern, Delores Borcherding, Joyce & Vince Sanfilippo, Cheryl Cantwell (in honor of her son-in-law), the Washington Garden Club, and all those who donated and were responsible for the decision to give donations from the Festival of Trees to WERF. Also, thank you to St. Peter's staff and members for always supporting us. We cannot thank you all enough.

From the Finance Board

The Finance Board is ready to keep you up to date with the finances of our church. We will continue to give you Stewardship Moments monthly.

First of all, Congratulations for coming through with your support and lowering the deficit in our budget. In November we were close to \$30,000 in the red. December was celebrated with generous giving! As of January 1, 2024, we had cut the deficit to less than \$12,000. Yes, we are still in negative balance, but we are ahead of a \$14,000 deficit on January 1, 2023. Of course, we would rather be at a positive balance, but we are making progress! Remember that giving was up-but of course so were expenses.

One big expense is insurance. The Finance Board worked with our agent Doug Dischinger of the Insurance Board to find savings in our policy but still receive adequate coverage. Other companies were researched but to no avail! It was to our advantage to stay with our present company and our overall costs did not increase.

Several changes have been made:

We are making monthly payments rather than quarterly payments (to help cash flow), the deductible amount was raised, flood insurance has been eliminated, and there is a change in the umbrella policy which created a grand total savings of \$6,374 per year. That is more than one month's premium in savings and another step toward lowering our expenses.

We are in a new year with new challenges! Hopefully you will help us get to a positive balance as we launch our new fund challenge:

"Have a Heart—Help the General Fund"

In the atrium you will find a red and white lighted tree. The envelopes on the tree have a dollar amount printed on the outside. We are asking you to take an envelope, fill out the card inside, place the suggested amount of money in the envelope, and place it in the decorated box. Cash amounts are from \$1 to \$100. When all the envelopes are returned, we will have gathered \$5,050! That will lower the deficit by almost half.

The Finance Board is doing its VERY best to get the money situation manageable. We have several more budget enhancement campaigns in store for you. We are planning a special presentation entitled Finance 101, to help everyone understand our church's finance. And we promise that there will be some "entertaining skits" ahead!

St. Peter's United Church of Christ Church Council Meeting Highlights 16 January 2024

Guest Report from Cemetery Board:

Jim Gephardt reported the Cemetery Board's vote to approve Gary Edler as the new sexton. Gary will take over the duties of the sexton except the digging of graves (outsourced to Jeff Adams at a cost of \$650/gravesite). The sexton's salary will be decreased by \$500/month. Jim thanked all the volunteers for their time and effort in keeping the cemetery beautiful. A motion was made and seconded to approve the hiring of Gary Edler as the new sexton. The motion passed.

Treasurer's Report:

The General Fund is still in the red (-\$11,800), but slightly better than last year at this time (-\$14,000). December's income was increased.

Discussion continued regarding suggestions to lower our insurance payments. Our current deductible is \$5,000. If we increase this to \$25,000, we will save \$3,938/year. Our agent suggested eliminating our flood insurance, as we are still covered for sewer backup, pipe breakage, etc., which would save \$1,427/year. If we change to a \$5 million umbrella liability policy from our current \$30 million policy, we will save \$1,009/year. Total savings of \$6,374/year.

A motion was made and seconded to approve these insurance changes. The motion passed.

A special meeting of the Council was called on Sun., Jan. 21, to conclude the Treasurer's Report approval. A motion was made and seconded to approve the Treasurer's Report. The motion passed.

Senior Pastor's Report:

Bible Study will restart January 17.

Visits to hospitalized members were curtailed for a while due to COVID quarantine. Thanks to my wife, Mary Schaller Blaufuss, for filling in during that time, and to Sara Barnett for her great job directing the children's Christmas Play.

Thanks to St. Peter's for my upcoming vacation time and the opportunity to join with Eden folks and travel to El Salvador. I've been invited to speak on this at the Women's Fellowship February meeting.

Associate Pastor's Report:

Sunday School took a break after their Christmas program and resumed on Jan. 7. He discussed the video sent to members about his music project/new church start. The Eastern Association approved and adopted his project, but there are no set financial obligations from them or the Conference. Up to \$22,000 in grants and start-up funding may become available, which could then allow a commensurate reduction in his salary support from St. Peter's. If this were to occur, it would also mean that Pastor Eric would split his time 75%/25% between St. Peter's and his music ministry. As of now he continues to be full time.

Boards and Committees:

Building and Grounds:

- There was furnace trouble due to boiler flushing delay.
- Pastor Kurt will renew our Missourian ad for a new custodian. Other suggestions included social media posts, asking other custodians for referrals, member cleaning teams, hiring a handyman as needed, being flexible in the number of hours/week.
- Discussed video camera mount in the balcony. B/G should discuss this with Jimmy Wacker.

Mission:

• Pastor Eric reported that they met last week and agreed to continue Mission Moments and discussed potential mission trip to Back Bay. Jill added that the group wants to better communicate to the congregation about groups that are invited to come speak.

Justice/Witness:

- There is a future "Lunch and Learn" concerning ONA (Open and Affirming).
- Salam Clinic had 5 patients in December.
- Some members want to attend the MLK service at ECC.
- There was a discussion on the homeless situation, with the library serving as a daytime warming station however those people need a secure area to store their belongings. He asked if St. Peter's might consider approving a locker system here, as has been done in some other communities. They will continue looking into options and update on total cost.

Old Business:

Constitution Review:

• Discussions regarding the cemetery perpetual care and the current wording in the Constitution continue. Pastor Kurt suggested a subgroup to continue research on this.

Website Review:

• The team met with Jason Oesterly, who was very helpful in pointing us in a more focused direction and suggesting possible templates and themes for us to consider. He will work up a site map/tree for us to use.

AED/LifeVac:

• There are pictures that can be used in the newsletter and bulletins to illustrate locations.

Update on custodian search:

• Pastor Eric posted on Facebook, WashMO, may post at the Career Center, and we could have flyers available for people who come through the church for Harvest Table and Food Pantry.

New Business:

Festival of Trees:

• There were 1785 visitors, including 78 for the Franklin County Church Tours on January 1. We collected \$1,091 and 8,543 food items.

All Boards and Committees Meeting:

- The meeting will be held on Jan. 21.
- It was suggested that each group select a few goals to meet during the coming year. We should consider strengths and weaknesses and how to rejuvenate and energize the whole body.

Brass Players for Easter:

• Ken Tucker asked about getting 3 brass players for Easter services. Council approved this but will check with him on total cost.
