St. Peter's UCC Missions in November 2023

WERF: In November, the Washington Emergency Relief

Fund received 289 calls. We were able to give out a total of 29 grants totaling \$6202.57. Sixteen of the grants were for electric, four for water, and nine for rent. These grants were able to assist 105

members of our county.

The Harvest Table: The Harvest Table provided 598 meals for their guests in

November. Besides nutritious, yummy food and fellowship for all, Blessing Bags, blankets, tents, sleeping bags, and

raffles for gift cards were given.

Salam Free Clinic: The Free Clinic provided services by a physician and nurse

to one needy patient in November. In addition to medical care by a physician, Nurse Leesa provided assistance to many at the Harvest Table. We are considering offering free

counseling services to support more people.

Food Pantry News Thank you to ALL the volunteers who help the food pantry

continue its vital ministry in our community. In November, 141 individuals representing 55 families were served. In addition to the regular amount of food given out, we gave Thanksgiving Turkey meals to 36 families consisting of 103 individuals. St. Peter's United Church of Christ Church Council Meeting Highlights 18 December 2023

Harvest Table Presentation:

Brenda Morman presented a check from the Harvest Table. They presented St. Peter's with \$2500 and an additional \$420 to cover half of the trash bill. We thank them for their donation!

Treasurer's Report:

As previously discussed, the insurance has been switched to 10 payments/year to split up the cost throughout the year, rather than having large expenses at once.

We are currently behind \$30,989 as of the end of November.

For the new year, we either must come up with new fundraisers, ways to reduce spending, or significantly reduce the budget.

A motion was made and seconded to approve the Treasurer's Report. The motion passed.

Senior Pastor's Report:

A written report was received. Activities are ramping up for Advent.

It was noted that the 7:30 Christmas Eve service will be live streamed.

Pastor Kurt will be out of town from December 26-January 2 and in El Salvador January 6-13.

Associate Pastor's Report:

A written report was received.

Messy Church was fun and meaningful on the first Sunday of December.

Pastor Eric updated us on his developments and activities with his other ministry, the All-In Music Project.

Boards and Committees:

Building and Grounds:

- Tripod mounts for camera in the balcony is under consideration. This would allow the cameras to be mounted to the railing and keep the tripods out of the walking path in front.
- Baby changing stations have been priced.
- The wall at corner of dining room and atrium, which has a damp spot, will be repaired.

Cemetery Board:

- Jeff Adams will be digging graves at the cemetery. He does this for many cemeteries in the area including Borgia and Oddfellows, and has his own equipment.
- A sexton hire is being considered. He would have all the other responsibilities except for digging graves.
- We are considering raising the price of plots.

Christian Education:

- The children's Christmas program was December 17.
- A SWOT analysis (strength, weakness, opportunities, threats) was done during the December meeting. The results will be passed to the new Board for consideration in 2024.

Old Business:

Website Review:

• This group met in late November and continues to revise text and find photos for inclusion on the website.

Members We Haven't Seen in a While:

• This item will be kept on the agenda for further review in future months.

New Business:

AED and LifeVac:

- We need to inform the full Congregation of the location of these. We would like it to be mentioned in the announcements for a few weeks. Marty will also write up an announcement to send to Carol for the Messenger and eMessenger.
- We should add its location to room maps.
- There was further general discussion on the room maps to add escape routes and tornado safety areas.
- We previously ok'd the purchase of additional LifeVacs and need to get these ordered.
- The current LifeVac is in the kitchen

Festival of Trees:

• To date, 1598 people attended and donated \$875 plus many items of food.



Mideast Realignment The United States and the

Middle East are at a crossroads. Despite a reduced presence in the Middle East, the U.S. still has significant national interests there, and the area is a key arena for global power politics. Can the U.S. continue to defend its interests in the Middle East and globally with a lower level of military and political involvement, or should it recommit to a leading role in the region?

Climate technology and competition Will the United States and China, with other powerful countries following suit, approach current and future climate initiatives with an increased commitment to trade protectionism and nationalism, by various measures including trade restrictions? Or could a growing spirit of international accord develop to confront the "common enemy" of climate change?

Science across borders Scientific advances benefit from collaboration between researchers, but what happens when material, such as Artificial Intelligence (AI) is controversial and important to a nation's national security? Is there a middle ground between sharing information and denying access? How can we regulate cooperation?

U.S.-China trade rivalry China's economic rise and its current policies of increasing the role of the state in the economy have led some U.S. policymakers to seek to deny China access to U.S. technology and investment. This is seen as a necessary corrective to decades of predatory Chinese economic policies. Is this a wise strategy, and how effective can it be?

NATO's future Since the Russian invasion of Ukraine in February 2022, the North Atlantic Treaty Organization (NATO) has come under increased scrutiny, not because NATO troops are involved in the conflict, but because of its role in relations between Russia and its neighbors. Will expanding membership in NATO protect countries, or will it further provoke Russia?

Understanding Indonesia Despite its large size, Indonesia remains virtually invisible to most Americans. But as one of the world's largest democracies, the world's largest Muslim-majority nation, and as an economic driver of ASEAN, why does it fly below the radar? What are current issues in U.S.-Indonesian relations, and what role can the country play in Asia?

High Seas Treaty Areas of the seas beyond national jurisdiction comprise the high seas, which are facing the degradation of ecosystems due to climate change and the increase in human activities, such as shipping, overfishing, pollution, and deep-sea mining. The recently negotiated High Seas Treaty, also known as the Biodiversity Beyond National Jurisdiction Treaty, will attempt to address these issues. How difficult will it be to convince nations to participate?

Pandemic preparedness Looking back at the COVID-19 pandemic, there are many lessons to take away in terms of domestic and international policies. Although this pandemic seems to have waned, how can we apply these lessons to future pandemics? Will countries cooperate, and will a consensus emerge on how to manage global health challenges?
